Other playgrounds recently completed or in the planning stages should be contacted and reviewed to help us make decisions regarding playground layouts, funding and grant sources.

Are the signs regarding picking up dog poop, especially in the areas used by school children, having any effect and how does this issue fit with the Town Forest Management Plan?

The Amphitheater was mentioned by the SB in regards to future planning.

The Town Forest Management Plan has been signed and the Recreation Committee has responsibilities. To be discussed at January meeting

The maintenance of the Town playground was discussed. The Recreation Committee needs to be aware of the chain of command when asking for help from Stephan.

## 10. Trails

Trails are closed with the goal to be ready for Spring. GMVS student volunteer looking for community service hours are a possibility.

## 11. Trails

Chris to leaf blow story walk and support installation of the new book for November. Berm on the nature loop still needs work, the Mad River Riders have not been responding, Chris to follow up. Likely they have been focused on the VOREC projects including the new bridge installed over the Millbrook. Pine Needle path logs have been cleared. Chris is working with a local couple that may be interested in helping with maintenance and some small rerouting to improve the current trail. We still need a leader to help with the reroute around the ECO classrooms.

Revised trail sign funding from the September meeting. Old motion: "Discussion of payment for the town's portion of creating the new sign map. Mike made a motion to approve a payment of \$600 from the 2024 Recreation Committee budget toward the cost of the sign. Neal seconded and motion was approved." New Motion: Chris made the motion to approve payment for \$499 from the 2024 Recreation Committee budget to the Mad River Riders towards the cost of the main trailhead sign replaced in August. Susan seconded, all approved.
